These terms are intended to protect both our clients and our technicians. By booking any service with Doug's Auto Detailing LLC, you agree to the policies outlined below.

### Cancellation & Rescheduling Policy

All appointments require a **20% non-refundable deposit (Up to a maximum of \$200)** to secure your booking. This deposit will be applied to your final invoice and can be transferred once if your appointment is rescheduled with appropriate notice. Missed or canceled appointments without 24-hour notice may result in forfeiture of the deposit.

If the deposit is not paid before service, it will be added to your total balance.

### Preparing for Your Appointment

Please ensure your vehicle is accessible and ready for service at the scheduled time. If our team must wait more than **10 minutes** due to excess trash, personal items, or lack of vehicle access, a **\$50 delay fee** may apply.

If the vehicle is not accessible within a reasonable time and results in a missed time slot, a **\$100 time-block fee** may be charged.

### Mobile Detailing Travel Fee

All mobile detailing services are subject to a **\$25 flat travel fee**. This fee covers travel time, fuel, and mobile equipment setup and will be added to the total service cost.

---

## Vehicle Condition Terms

Please remove all personal belongings prior to your appointment. Doug's Auto Detailing LLC will not clean or move the contents of glove boxes, center consoles, or storage areas that contain personal items.

For your safety and ours, we do not uninstall car seats. If a child seat is left in the vehicle, we will clean around it to the best of our ability.

Please inform us in advance of any excessive or hazardous conditions including:

- Pet hair
- Mold or mildew
- Bodily fluids
- Odors or strong stains
- Excessive trash

Failure to disclose these conditions may result in **additional fees** or service refusal.

We do our best to improve interior and exterior conditions, but we do **not guarantee** complete removal of all stains, odors, or buildup—especially on delicate or damaged materials.

## Exterior Notes

Bug splatter, sap, tar, and bird droppings can chemically etch clear coat if not addressed quickly. While we will work to minimize or remove these defects, some damage may be permanent.

Trim restoration and brake dust removal are offered as part of specific services but are **not guaranteed** for vehicles with severe degradation or neglect.

## Service Area Safety

Please keep a **safe distance of 10–15 feet** while we work. Our equipment includes hoses, power cords, and chemicals that may pose a trip hazard.

If unsafe or hazardous conditions are discovered (biological waste, chemical spills, etc.), we reserve the right to stop service and charge a partial fee.

## Satisfaction Guarantee

If you believe a part of your service was missed or not performed to standard, please contact us **within 24 hours** with photo documentation. We will offer a redo or partial refund at our discretion.

Refusal of a redo appointment limits refunds to **20% of the total service cost.**

## Payment Policy

Full payment is due **immediately after service completion.** We accept Cash, credit/debit, Visa, Mastercard, American Express, Discover, Apple Pay and Google Pay.

Delays in payment or repeated cancellations may require full prepayment for future appointments.

## Estimates & Inspections


